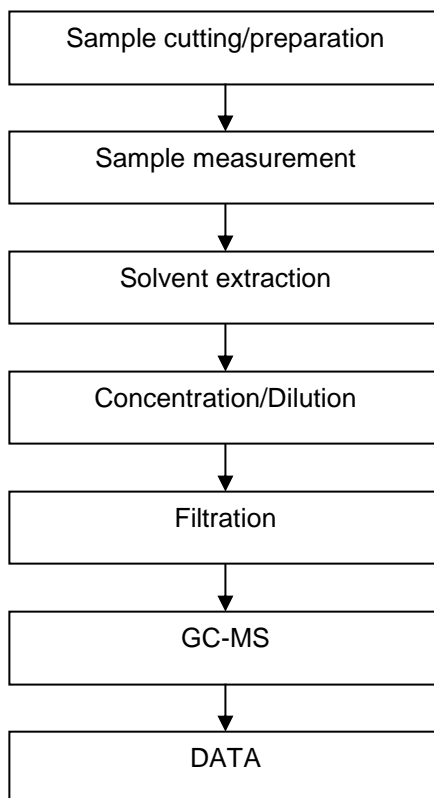

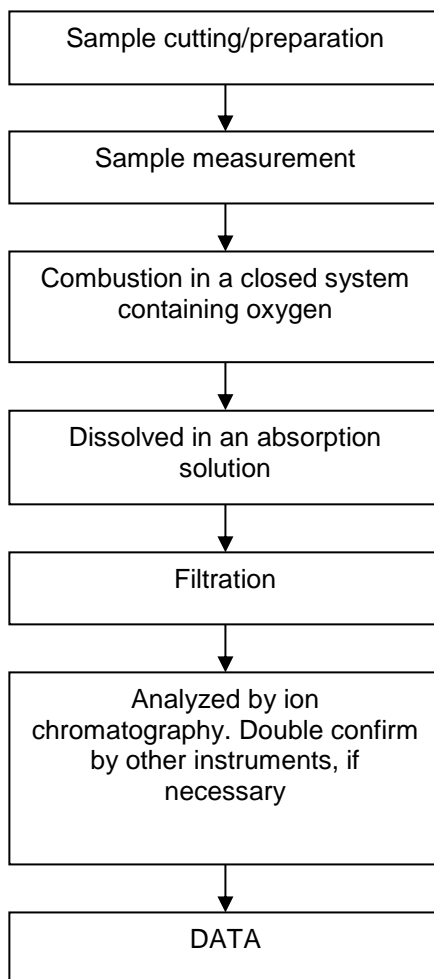

## Halogen Testing Flow Chart



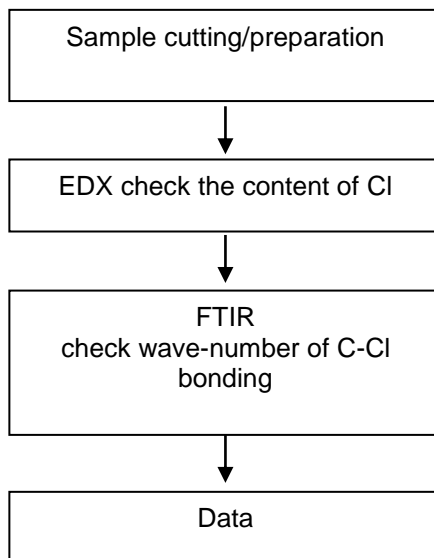

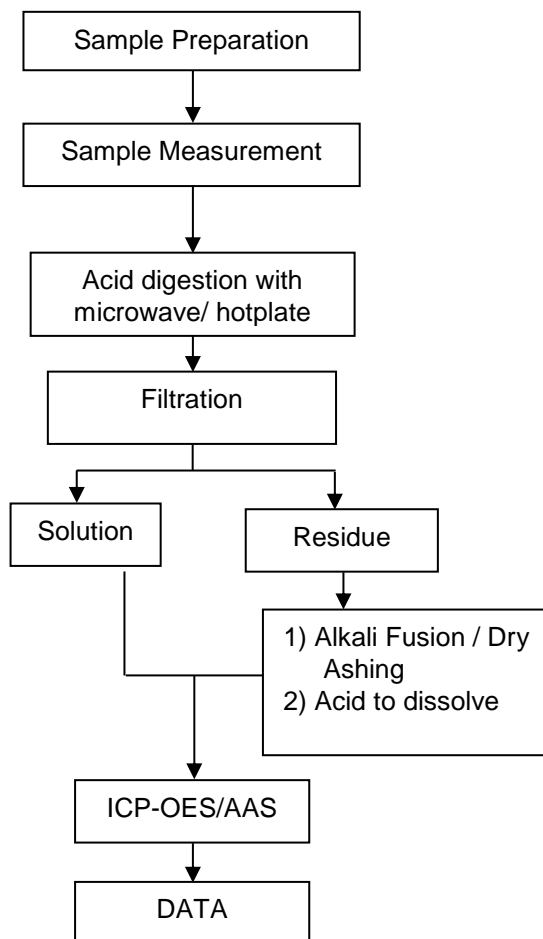

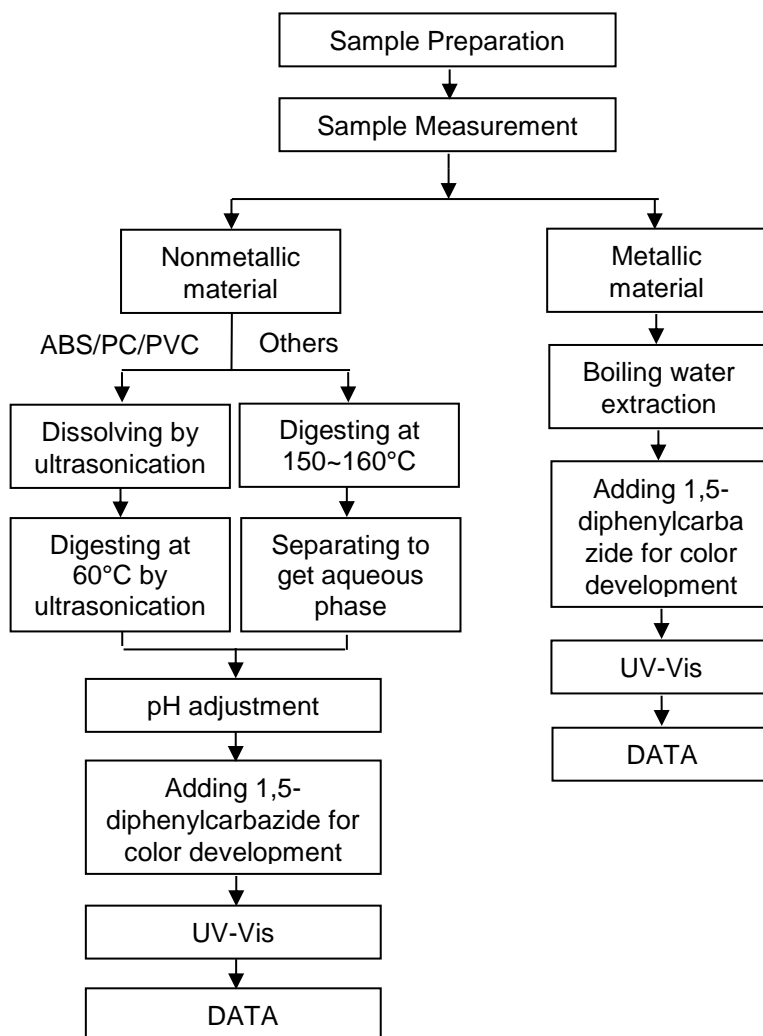
### Elements Testing Flow Chart

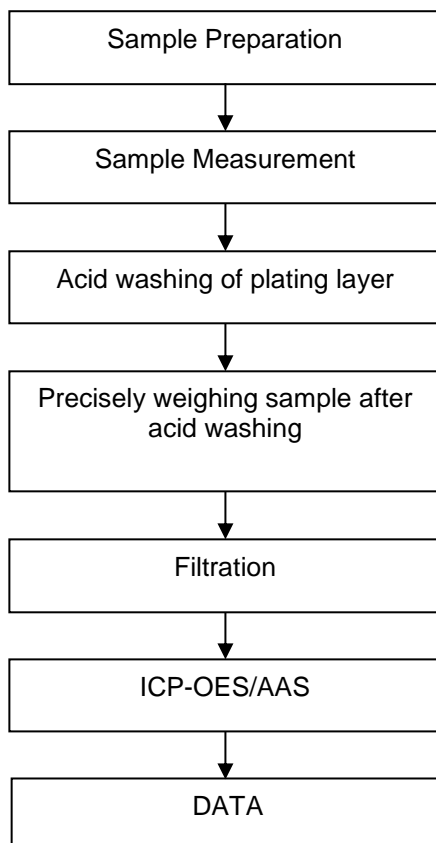

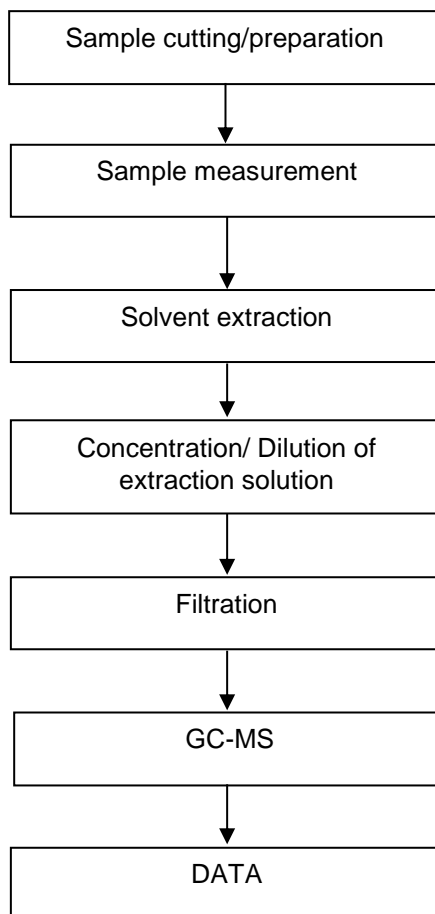
### Hexavalent Chromium (Cr(VI)) Testing Flow Chart

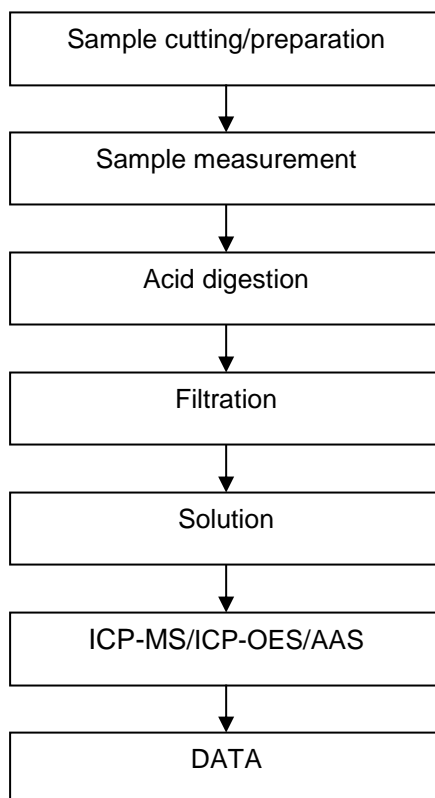
